This announcement is made pursuant to the disclosure obligation of the Company under Rules 13.14 and 13.15 of the Listing Rules which arose from the increase of the Group's total advance to the Customer Group together with another company affiliated with the members of the Customer Group by more than three per cent. from the percentage with reference to the Company's total market capitalisation previously disclosed in the Announcement under Rule 13.13 of the Listing Rules.

Reference is made to the Company's announcement ("Announcement") dated 31 March 2004 and made pursuant to Rules 13.13 and 13.15 of the Rules ("Listing Rules") Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited ("Stock Exchange"). The Announcement disclosed, among others, that the total trade receivables from a group of customers of the Group which are affiliated companies of one another (collectively, "Customer Group") comprising Canon Zhongshan Business Machines Co, Ltd., Canon Zhuhai Inc., Canon Logistic Inc. and Canon Engineering (H.K) Co., Ltd. amounted to a total of approximately HK\$35.2 million as at 30 March 2004 which equaled to approximately 17.8 per cent. of the Company's total market capitalisation as at 31 March 2004.

Under Rules 13.14 and 13.15 of the Listing Rules, a disclosure obligation arises where the total advance to an entity together with companies affiliated with it from V.S.
